For the sum of \$ _____ plus \$ _____ for shipping, with \$ _____ for deposit, \$ _____ due at 4 weeks old and the balance of \$ _____ due at time of pickup (Shipping costs are due 1 week prior to shipping). If puppy is not picked up by 8 weeks old there will be a \$25 a day fee. After 7 days all monies received will be forfeited and puppy will be relisted for sale. _____ *initial*

- Once the litter has been bred, all deposits and monies are non-refundable, if the selected color/sex is not born in the litter, your deposit will be moved to the next litter. _____ *initial*
- Once you have picked a puppy, there is no changing to another puppy. _____ *initial*
- Tails are docked long per AKC and dewclaws are removed by 3 days old. If you choose to not have either one or both done, the full price of the puppy is due when they are 2 days old and that pup will be yours and you ***Can Not*** make any changes as to which pup you chose. If you back out all monies will be forfeited completely. _____ *initial*

1) The **Buyer** agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available at all times. The **Buyer** promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision. The **Seller strongly recommends** that the puppy/dog be micro-chipped in order to facilitate his return if lost or stolen. _____ *initial*

2) The **Seller** guarantees this puppy/dog to be of sound health and temperament at the time of this sale. A health record of all shots and/or worming will be provided by the **Seller**. The **Buyer** agrees to take this dog to a **licensed veterinarian** of their choice within 48 hours for a physical examination. Should puppy be determined to have genetic defects, the cause of which the **Seller** is clearly to blame, the dog may, upon a signed written diagnosis from said licensed veterinarian, be returned for refund of the purchase price. The **Seller** assumes absolutely no responsibility for fees associated with caring for the puppy. No other guarantees are given. ____ *initial*

3) If at any time the **Buyer** can no longer retain possession of this dog, the **Seller** is to be notified and given first option of resuming full ownership of dog in order for the **Seller** to locate this dog a new home. Refunds, if any, will be at the discretion of the **Breeder/Seller**. The dog will be returned with all AKC papers and medical records. Should any circumstances arise that affect the quality of life of the dog, the **breeder/Seller** is to be informed so that they may participate in determining the future of the dog. The **Breeder/Seller** reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility. ____ *initial*

4) The **Buyer** agrees to contact the **Seller** immediately if any questions or concerns arise about the dog, such as housing, diet, or health. The **Buyer** agrees to keep the **Seller** informed of any treatment as it occurs. This provides the **Breeder/Seller** with an opportunity to follow up on puppies and gives us important feedback and information on the health of our dogs for future generations. ____ *initial*

5) This puppy is being purchased as a pet only and will need to be taken to a certified veterinarian to be spayed/neutered by the time the puppy is 6 months old. A physical veterinarian receipt with a letter must be provided within a reasonable amount of time of the 7th month as proof that the poodle is unable to reproduce. If anyone breeds the Standard poodle, the owner(s) must surrender their rights of ownership of the Standard poodle as well as any offspring the animal produces. Additionally, any monies made from the offspring shall be surrendered to Austin R. Charleton. Any costs associated with the return and/or recovery of the animal, including court costs, will be paid by the Buyer. A refund will not be given if the animal is taken back for failure to have the animal spayed/neutered. ____ *initial*

The preceding paragraphs contain conditions established by the **Seller** to ensure the wellbeing of the puppy/dog. The **Buyer's** agreements will continue for the duration of the dog's life and the **Seller** will have the right to enforce the agreements. These terms and conditions and the transactions contemplated hereby shall be governed by, and construed and interpreted in accordance with, the laws of the State of Arizona, U.S.A., without regard to the choice-of-law principals thereof. Any action seeking legal or equitable relief arising out of or relating to these terms will be brought only in the courts of the State of Arizona or the United States District Court for the District of Arizona. ____ *initial*
